The Society collects personal data from members and those with whom it regularly deals in the form of names, titles, addresses, telephone numbers and email addresses plus, where applicable, details of Gift Aid declarations.

This data will be processed and used for the purposes of:

1. maintaining contact with members and others generally, in particular circulating newsletters, walk programmes, changes to the published details of walks and details of social events as well as other material relevant to the interests and purposes of the Society
2. the administration of the affairs of the Society, in particular circulating material relating to general meetings to members and communicating with those with whom the Society regularly deals
3. maintaining records of current members and administering the payment of subscriptions
4. filing returns with HMRC in relation to Gift Aid.

By becoming and/or remaining a member, individuals consent to the use of their data as set out in 1-3 above. Data will be used under paragraph 4 as required by our legal obligations.

Membership data will be retained for so long as an individual is a paid-up member and for a period of 1 year after membership expires or, if longer, for so long as required by law. It will then be deleted.

Membership data may be stored in personal computers and/or on other electronic devices belonging to the Chair, the Membership Secretary, the Secretary and the Treasurer so may be backed up to third party storage sites such as the Cloud, Google, Dropbox, OneDrive and the like.
